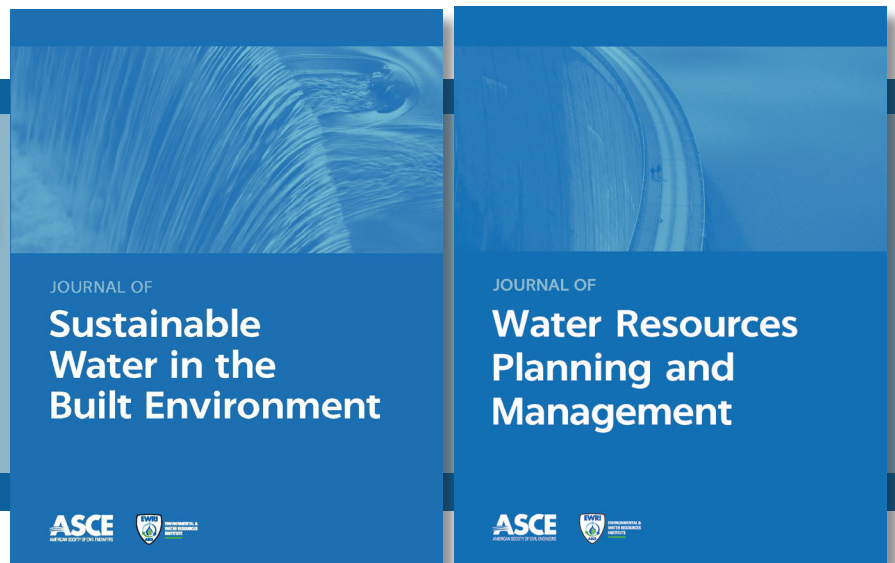

Joint ASCE Special Collection on Water Equity



Aims & Scope

This special collection will highlight novel research that characterizes, analyzes and critiques inequities and water injustice and provides local, regional, and global solutions toward water justice and equity. We invite authors to contribute articles that address and illuminate barriers and solutions to achieving water equity and justice, particularly those aspects related to diverse and under-represented groups and marginalized and economically disadvantaged communities. Research that sheds light on and engages communities that have historically been excluded from water governance and management and development of drinking water, wastewater and stormwater technologies is especially encouraged.

Specific topics of interest include but are not limited to:

- Environmental and water justice and the disproportionate burden on marginalized communities (e.g., migrant workers), under-represented groups, diverse groups (e.g., women) and disadvantaged communities;
- Challenges and solutions for access to safe, affordable water infrastructure for under-represented (e.g., Black, communities of color, indigenous), economically disadvantaged and shrinking communities;
- Challenges and solutions for access to safe, affordable water infrastructure for unhoused populations and in informal, unbounded and extra-legal communities and settlements;
- Equity issues related to green and grey stormwater infrastructure and its impact on access to green space;
- Legal, political and policy aspects related to lack of access to water;
- Climate justice and the disproportionate impact of climate change related to water and disadvantaged communities;

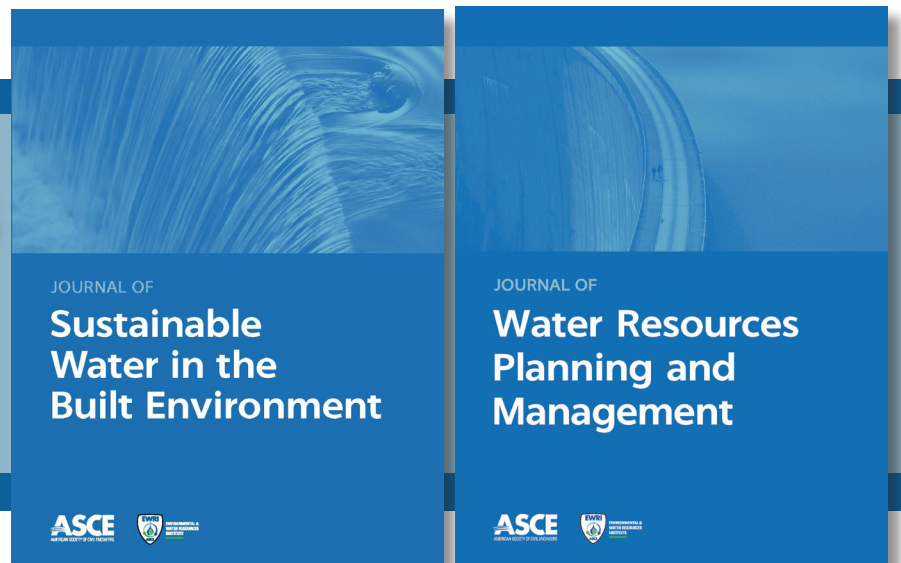

Manuscript Submission

Authors should prepare their manuscripts in accordance with the ASCE Author Guide. In addition, as part of the submission process, authors will be required to explain the novelty of the work described in the paper.
