

Aims & Scope

Building and facade inspections are now considered integral parts of an overall management plan for longevity and failure prevention, especially in high-rise buildings. A program of routine inspection and maintenance, complemented with nondestructive testing and monitoring, is an effective method of identifying the cause and severity of distresses and prescribing remedial actions to prevent failure. The sudden failure of June 24, 2021 of the Champlain Towers South Condominium in Surfside, Florida, has brought much attention to, and placed a great emphasis on, the subject of building inspection and failure prevention. 
